Welcome to The construction site

Goal

CLIENT's goal is 0-accidents. This is secured through active security work including everyone working on the site.

Tidiness

Each entrepreneur must continuously, and on a daily minimum, clean up after him or herself as well as remove garbage and dust from the construction site.

Access road

The marked access routes to the construction site must be used

The Safety work

Everyone has a duty to actively participate in safety activities at CLIENT's building site. Safety round is conducted <day and time>. < day and time > the safety group of the firm participate in the safety meeting.

Accidents and "almost"-incidents

All accidents and "almost" incidents MUST be reported to the safety coordinator immediately. The employer must examine all accidents and "almost" incidents and report to the safety meetings. Contact the safety coordinator who will hand out a scheme for examination of the accident or "almost" incident.

Do not pass!!

Everyone has a duty to call attention to things, which means the risk of accidents. Do not pass - correct the error. Is it not possible, report it to your safety representative, supervisor, construction management or safety coordinator.

Instruction and supervision

All employees must be instructed thoroughly in their work by the foreman. The work must be supervised to ensure that the instructions/risk assessments are followed. Regarding all especially dangerous work, the employer in writing must evaluate the risk and suggest safety measures cf. the scheme for evaluation of risks.

Education

No one shall operate or use material that they do not have the right training and certificate to. Members of the safety group must have attended the mandatory safety education.

Personal protection

There must be used helmets, xxxxx and safety shoes throughout the construction period. Safety glasses is used for work where there is risk of dust, splinters or similar. Other protective equipment shall be used as needed. There will be a sign at the entrances to the CLIENTs building site.

Inspection and approval

It is required that all equipment/technical aids that are used at CLIENTs building site is inspected, mandatory inspections, are in working order and have the required approvals. All other equipment must not be used on site.

Alcohol and other drugs

There's alcohol ban on CLIENT's building sites. Ingestion of alcohol or drugs at the site is reason for deportation from the construction site.

Smoking Policy

Smoking is ONLY allowed outdoors. The shutters must be collected.

Eating

All eating takes place in the site hut.

Guests at the site

It is not allowed for people without security clearance to stay at CLIENT's construction site without preceding contact with management.

Particularly hazardous area

When hoisting of materials, the management must be contacted before for closer coordination and isolation.
